### **Terms and Conditions Please read and sign**

By signing this contract, the Client/Team/Organization/Representative (hereafter referred to as the Client) agree to the following terms and conditions:

1. All activities on the date(s) of the facility rental, including cleanup, shall conclude no later than the scheduled end time. The Client will not be provided with additional time for equipment clean-up. All property belonging to the Client or its contractors shall be removed no later than the sessions end time on the day of the reservation.
2. All guests attending the event shall remain within the designated areas that are rented by the organization.
3. Between The Lines Sports Inc will not be held liable for any property left on the premises after the bookings or facility use after conclusion.
4. Between The Lines Sports Inc maintains general liability, fire, and property insurance. However, Between The Lines Sports Inc's insurance policies do not cover or protect against loss of Client's property or damage or injury to Clients, their guests or their property.
5. A payment method is to be provided upon signing of this contract. Post-dated cheques or a credit card number are both acceptable forms of payment.
6. A session or rental within the contract can be rescheduled by the Client when Between The Lines Sports Inc is provided a minimum of 24 hours notice.
7. Between The Lines Sports Inc reserves the right to reschedule a booking by the Client within 48 hours prior to the scheduled start time of the rental.
8. Refunds will not be provided for no-shows or when less than 24 hours notice is provided for rentals to Between The Lines Sports Inc by the Client prior to a cancellation.
9. Permission is given to the Between The Lines Sports Inc, and/or parties designated by the Between The Lines Inc to photograph/video me and use such photograph(s)/video(s) in all forms of media, for any and all promotional purposes including advertising, display, audiovisual, exhibition or editorial use. The Client understands and agrees that they will not receive any payment for my time or expenses or any royalty for the publication of the photograph(s)/video(s) or the use of their name and the Client hereby release the Between The Line Sports Inc. and/or any parties designated by Between The Line Sports Inc. from any such claims.
